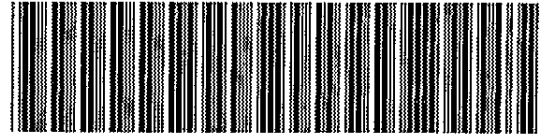

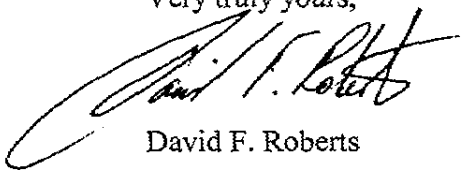

ARTICLE I - Name

The name of the Corporation is Compusmart Solutions, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - Purpose

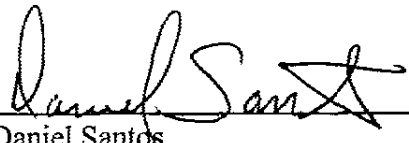
ARTICLE VI - Incorporator
