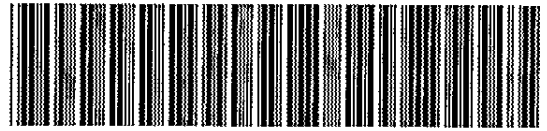

ARTICLES OF INCORPORATION
OF
PENSACOLA TOWER SERVICES, INC.

ARTICLE I

The name of this corporation is: **PENSACOLA TOWER SERVICES, INC.** The principal address and mailing address of this corporation is 2852 Pine Forest Road, Cantonment, Florida 32533.

ARTICLE II

The purpose of this corporation is for the installation and maintenance of communication towers and any and all other lawful business.

ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 5,000 shares of \$1.00 par value common stock.

ARTICLE IV - PRE EMPTIVE RIGHTS

Each shareholder upon the sale for cash of any new stock of this corporation of the same kind, class or series of that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price of which it is offered to others.

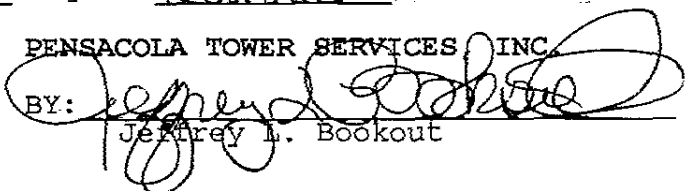

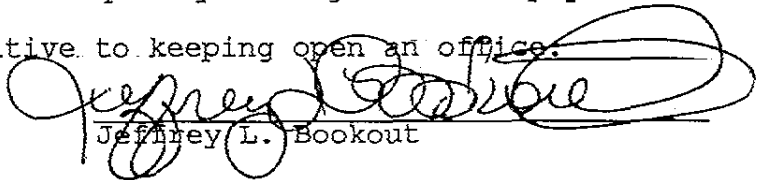
