

Eduardo Posada, the undersigned, being of the age of eighteen (18) years or more, do hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

1. The name of the Corporation shall be: Gold Leaf Finishes, Inc.
2. The number of shares the corporation is authorized to issue shall be 1000 shares all of one class designated as common stock, at \$ 1.00 per value.
3. The street address and county of the initial principal office of the corporation is 8110 SW 205 St, Miami, Fl. 33189 Miami-Dade County and the name of the initial registered agent at this address is Eduardo Posada , residing at 8110 SW 205 St., Miami, Fl. 33189
