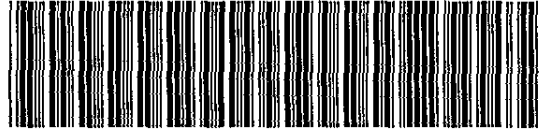

ARTICLES OF INCORPORATION OF  
WARSOWE PROPERTIES, INC.

ARTICLE I

NAME

The name of the corporation is WARSOWE PROPERTIES, INC.



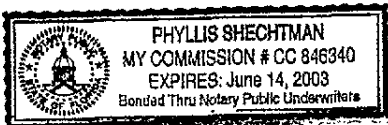
