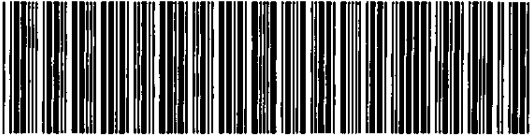

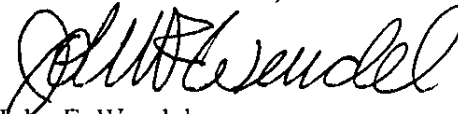

**ARTICLES OF DISSOLUTION  
OF

Club Hill Estates, Inc., a Florida corporation, files these Articles of Dissolution pursuant to Sections 607.0120, 607.0123, 607.0704, 607.1402(6), and 607.1403, Florida Statutes:

**ARTICLE I.**

The name of the corporation is Club Hill Estates, Inc., and the Department of State of the State of Florida document number is P02000116595.

**ARTICLE II.**

The dissolution of the corporation was authorized on April 30, 2007.

**ARTICLE III.**

The dissolution of the corporation was approved unanimously by all of the shareholders. The number of votes cast for the dissolution was sufficient for approval. Voting by voting groups was not required.

**ARTICLE IV.**

The effective date of the dissolution of the corporation shall be the date on which the Articles of Dissolution are filed in the Department of State of the State of Florida, pursuant to Sections 607.0123 and 607.1403, Florida Statutes.
