

ARTICLES OF INCORPORATION

OF

NINO HOME HEALTH CARE, INC.

ARTICLE I - NAME

The name of this Corporation is NINO HOME HEALTH CARE, INC.

ARTICLE II - DURATION

The Corporation shall have perpetual existence commencing on the dates these Articles of Incorporation are filed with the Florida Secretary of State's Office.


ARTICLE XI - INCORPORATOR
