## ARTICLES OF INCORPORATION OF RED DRAGON, INC.

#### Article 1

Name. The name of this Corporation is RED DRAGON, INC.

#### Article II

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: 1800 N.W. 30<sup>th</sup> Terrace, Gainesville, Florida, 32605.
