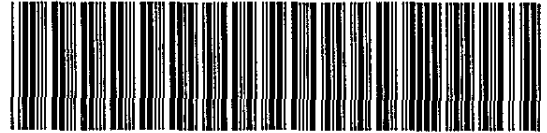

ARTICLE I - NAME

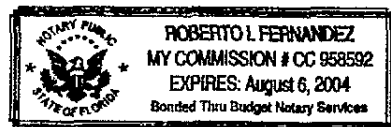
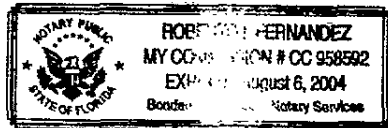
