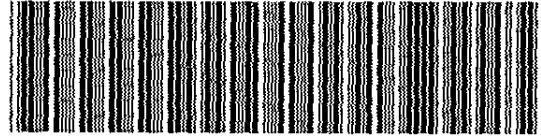

- (D) To acquire real and personal property

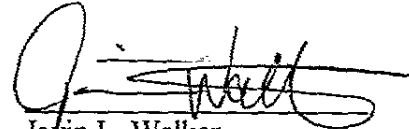

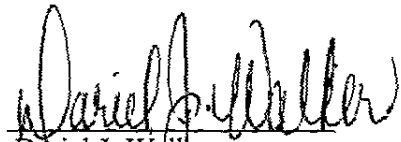
