

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be **JIM WEINBERG DESIGN & DEVELOPMENT, INC.**



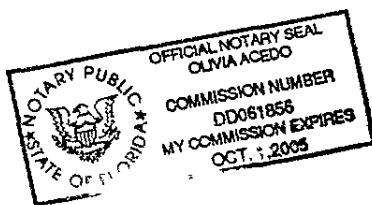
