ARTICLES OF INCORPORATION

Pursuant to Chapter 621 of the Florida Statutes, the undersigned, being a natural persons does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a professional services corporation.

ARTICLE I - NAME

The name of the corporation is Robert Ciccia-MacLean, M.D., P.A. (hereinafter called the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE
