**ARTICLES OF INCORPORATION
OF
ALFONSO O. TOLENTINO, M.D., P.A.**

Pursuant to Chapter 621 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a professional services corporation.

ARTICLE I - NAME

The name of the corporation is Alfonso O. Tolentino, M.D., P.A. (hereinafter called the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE

The street address of the initial principal office and mailing address of the Corporation is 4300 Alton Road, Suite 207, Miami Beach, Florida 33140.

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of providing professional medical services.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 1,000 shares of Common Stock, par value \$.01 per share.


