**ARTICLES OF INCORPORATION  
OF  
THE LAW OFFICES OF SUZANNE K. STERLING, P.A.  
A Florida Business Corporation**

The undersigned, acting as incorporator of a business corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such business corporation:

**ARTICLE I -- NAME**

The name of the business corporation shall be The Law Offices of Suzanne K. Sterling, P.A. (the "Corporation").

**ARTICLE II -- PRINCIPAL OFFICE**

The principal place of business and mailing address of the Corporation shall be 1792 Bell Tower Lane, Weston, Florida 33326.

**ARTICLE III -- REGISTERED AGENT**

The street address of the Corporation's initial registered office is 2513 Poinciana Drive, Weston, Florida 33327 and the name of its initial statutory agent at such address is Suzanne K. Sterling.

**ARTICLE IV -- DURATION**

The duration of this Corporation shall be perpetual.

**ARTICLE V -- PURPOSE**

The purpose of the Corporation is to engage in the practice of law and to conduct any and all lawful activities or business under the laws of the United States of America and State of Florida, provided, however, that professional legal services shall be rendered only through officers, employees, agents, and independent contractors who are duly licensed to practice law under the laws of the State of Florida.

The Corporation may do all and every thing necessary, advisable, proper, or convenient for the accomplishment of, attainment of, or furtherance of any of the purposes or objectives set forth in these Articles of Incorporation or any amendment thereof, and to do all other things incident thereto or connected therewith, which are not forbidden by the Florida Business Corporation Act, otherwise by law, or by these Articles of Incorporation.

purposes shall not be held to limit or restrict in any manner the purposes or powers of the Corporation otherwise permitted by law.

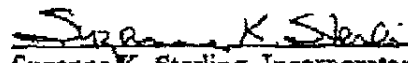
**ARTICLE VI -- CAPITAL STOCK**
