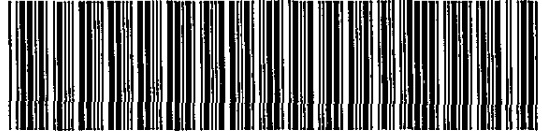

The undersigned, for the purpose of forming a Florida corporation pursuant to Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be: **UPDATED.COM, INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
300 South Pointe Drive, Suite 3704, Miami Beach, Florida 33139.

ARTICLE III. CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at one time is 100,000,000 shares of common stock, with no par value.

Authorized capital stock may be paid for in cash, services, or property, at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting. The initial capital contribution by the Nicholas Papadopoulos, as the Incorporator and sole shareholder shall be Three Thousand and No/100 Dollars (\$3,000.00).

Preemptive rights shall exist for the new issuance of capital stock, subject to exceptions for (i) shares issued to employees or executives of the corporation as compensation; (ii) shares issued within six months after incorporation; (iii) shares issued for services or property other than cash; (iv)

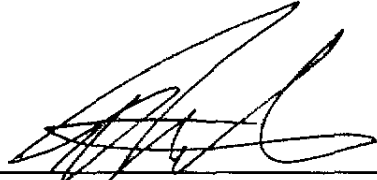
These Articles of Incorporation shall be effective on the date of the filing of these Articles of Incorporation with the office of the Secretary of State of the State of Florida.

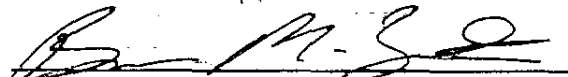
