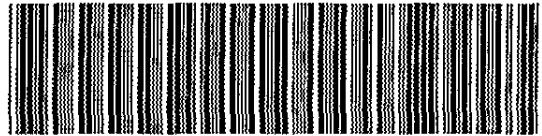



ARTICLE I.
