ARTICLES OF INCORPORATION OF <u>Volzyra, Inc.</u>

FILED SECRETARY OF STATE DIVISION OF CORPORATIONS

The undersigned subscriber of these Articles of Incorporation, a natural personal competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME
