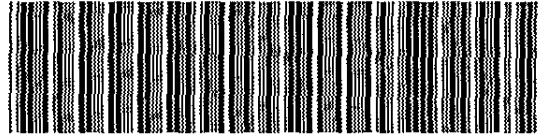

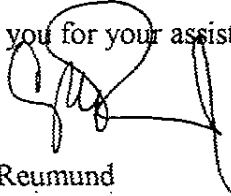

**ARTICLES OF INCORPORATION of  
SAFEFIX, INC**

To the Secretary of State of the State of Florida:

I, the undersigned, acting as Incorporator of a Corporation under the Florida Business Corporation Act, pursuant to Chapters 607-621 F.S., adopt the following ARTICLES OF INCORPORATION for said Corporation.

**ARTICLE 1.**

The name of the Corporation is Safefix, Inc

**ARTICLE 2.**

The duration of the Corporation shall be perpetual.

**ARTICLE 3.**

The purpose for which the Corporation is organized is to engage in any or all lawful businesses for which a Corporation may be organized under the laws of the State of Florida.

**ARTICLE 8.**

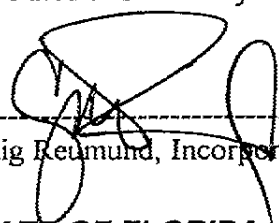
The Corporations financial year will end on December 31, each year

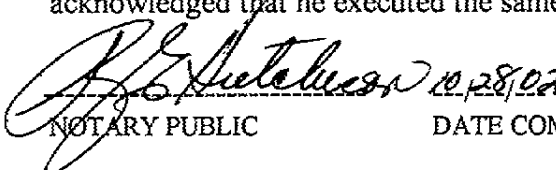
