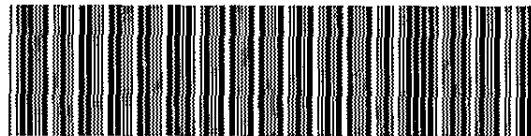

ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation shall be:

Fideligent Construction Corporation.



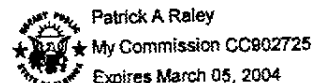
