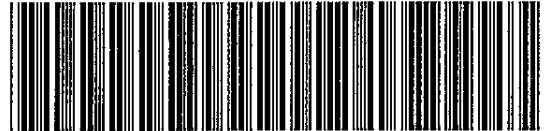

ARTICLE I

ARTICLE II

This Corporation shall exist perpetually.

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

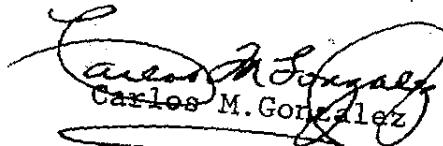

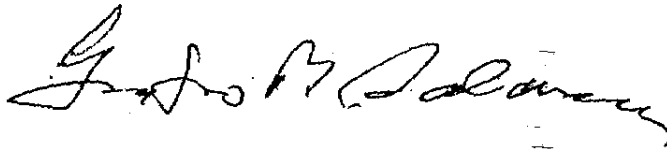
