
Gentlemen:

Recently our client, Phillips DTW Enterprises, Inc., received an annual report for calendar year 2003. According to the notice because they failed to file by May 1, 2003 the \$150.00 fee has increased to \$550.00 through September 10, 2003. We have reviewed our files and discussed this matter with our client. As a result of this action we are requesting a reduction of the current fee of \$ 550.00 to \$ 150.00.

When our client originally incorporated they were planning to purchase and operate a business located at 4411 Bee Ridge Road in Sarasota, Florida. That is the address shown on the original incorporation papers and where the original Annual Report was mailed.
