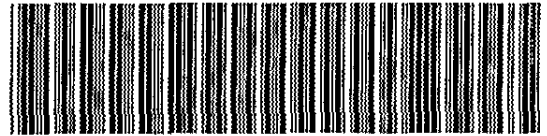

ARTICLES OF INCORPORATION

OF

ARTICLE 1. - NAME

The name of the corporation is JENS ALBIEZ INTERIORS, INC.




