ARTICLES OF INCORPORATION

OF

CONCOCTIONS GIFT GALLERY, INC.

ARTICLE I

The name of this corporation shall be CONCOCTIONS GIFT GALLERY, INC., Fand its principal address is 8445 Boxwood Drive, Tampa, Florida 33615.
