We filed the UBR for Dreams of Wellness, Inc. on April 10, 2003 accompanied by its check in the amount of \$150.00 (copy of canceled check front and back enclosed). The check cleared the Dreams of Wellness, Inc. bank account on April 18, 2003.

The next contact we had with your office was when we received another UBR with the notice that it had to be filed not later than September 10, 2003 or a reinstatement fee of \$600 would be levied.

This morning I called 1-850-245-6059 Option 4 for an examiner and was told that the UBR was incomplete (the FEIN had not been entered and therefore, the UBR was not accepted. I asked how I would know this. The reply was that a notice was sent to that effect. I stated that was incorrect and NO NOTICE HAD BEEN RECEIVED BY US. I mentioned that the check had cleared the bank on April 18, 2003 and in view of no further notice from the Division, we reasonably thought the report had been received and accepted. The gentlemen to whom I spoke said that if I put this information in writing to you, you would make the appropriate notations on the internet website showing the corporation to be in good standing. At the present time (even though the check cleared and the report was not returned and no notice of unacceptability was received) - the corporation shows as not in good standing with the State of florida.

We are sending ANOTHER UBR along with the check copy so that you can change the status of Dreams of Wellness, Inc. to "in good standing".
