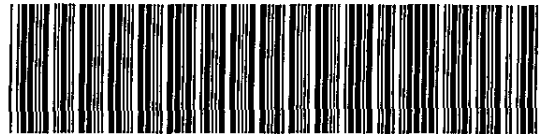



The name of this corporation is MDS DEVELOPERS, INC.

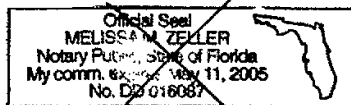



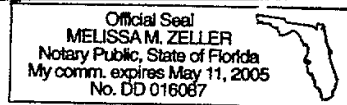
