To Whom It May Concern,

Per the advice of my accountant I am writing to you pertaining to the UBR report for Eterna, Inc., as well as enclosing a check in the amount of \$150.00 for the filing fee.

First, I was sent a UBR pertaining to the corporation named "Chopping Block" that does not exist. My accountant Mr. Hal Jacobs of Jacobs Accounting located in Dunedin Florida legally changed the name in November of 2002. To this date I still receive documentation under "Chopping Block" that I send back. However, in this case I was waiting for the UBR to be sent in the proper name of Eterna, Inc., which never arrived. In the mean time my father in-law passed away in April and we quickly left for Maryland to meet with the family and then on to Nigeria for the burial. I have enclosed documentation of my husband's Nigerian citizenship as well as the death certificate, travel information and other supporting documentation of our leaving the country. Since we left in a hurry I was unable to legally assign my accountant as the registered agent to submit the UBR. Since our returning this past month and going through the mail I am submitting the UBR sent to me.

Please accept our check in the amount of \$150.00 for the filing of our corporate UBR. The death of Emee's father was beyond our control and we had to leave as soon as we could because my husband is the first-born son. The burial, traveling, legal and family expenses to finalize the families affairs in Nigeria took more time and money than we could bear. Like many other families and business throughout the United States we are doing all we can to survive and overcome. I pray you accept this amount for the UBR filing and will not assess any other charges.
