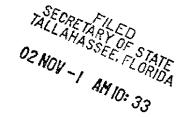

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

# ARTICLE I Corporate name

The name of the corporation is Ricardo's Tango, Inc., hereinafter referred to as the "Corporation."
