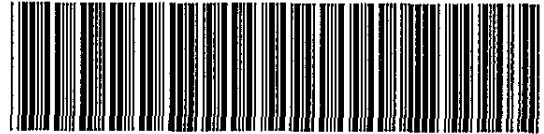

We, the undersigned do hereby join together in the formation of a for-profit corporation, following the terms and conditions to wit:

**ARTICLE I**

The name of the corporation shall be:

**Principal Place of Business:**
