OF

ARTICLE I. NAME

The name of this corporation is
CASEL ENTERPRISES, INC.

ARTICLE II. DURATION

This corporation shall commence January 1, 2003 and
shall have perpetual existence.

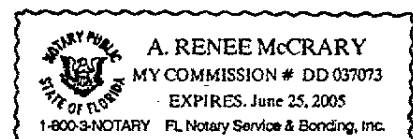


