ARTICLE I.

The name of this Corporation is: OCEANA ADVERTISING, INC.

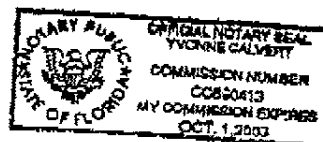

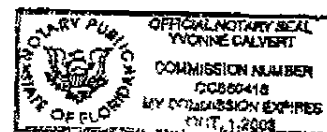
