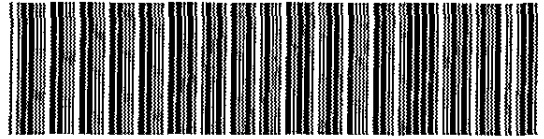

ARTICLES OF INCORPORATION

Article 1. The name of the corporation is DKP ELECTRICAL SYSTEMS, INC.
