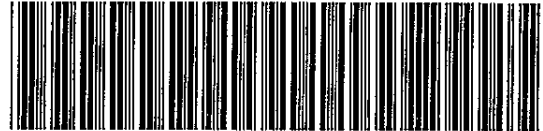

ARTICLE I - NAME

The name of this corporation is RED LOTUS CORPORATION.


