I, the undersigned incorporator of this corporation under chapter 607, Florida status, as amended, adopt the following Articles of Incorporation:

ARTICLE I- NAME

The name of the corporation is: MATRACO INVESTMENT FLORIDA INC.

ARTICLE II- PURPOSE

The general nature of this business to be conducted by this corporation is:

- 1- To represent and distribute the construction materials of MATRACO world wide and all related other products of the company.
