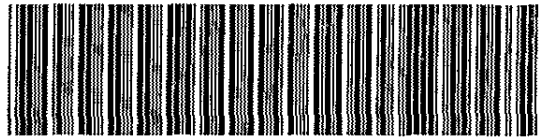

**Articles of Incorporation of Glacier Construction Services, Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME. The name of the corporation shall be Glacier Construction Services, Inc.

ARTICLE II. PURPOSE. The purpose of the corporation shall be any and all business permitted under the laws of the State of Florida. The corporation may own real property and undertake any other lawful activity in the furtherance of the purposes set forth.

ARTICLE III. PRINCIPAL OFFICE. The address of the principal place of business of this corporation shall be 7151 290th St., Branford, Florida 32008, and the mailing address of the corporation shall be P.O. Box 299, Branford, Florida 32008.

ARTICLE IV. CAPITAL STOCK. The number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock, with a par value of \$1.00.

ARTICLE VII. DIRECTOR. The initial director of the corporation is Jonathan G. Deans, whose address is 7151 290th St., Branford, Florida 32008. The number of directors may be raised or lowered by amendment of the bylaws of the corporation but in no case shall be less than one.
