These Articles of Amendment are hereby filed The Lartie STATE Articles of Incorporation of Southeast Utilities Group, Inc., a Florida corporation.

At a joint meeting of the shareholders and directors of Southeast Utilities Group, a Florida corporation (the "Corporation"), held on June 28, 2006, at which all of the shareholders and directors of the Corporation were present, the following resolution was unanimously adopted:

"RESOLVED, that the following changes be made to the Articles of Incorporation of Southeast Utilities Group, Inc., a Florida corporation:

- 1. Article Four is to be amended so that the aggregate number of shares which the Corporation is authorized to issue is 2,000 shares, all of a single class and each having a par value of \$1.00.
- 2. Article Six is to be amended so that the Corporation may have as many as four directors constituting the board of directors of the Corporation.

Said amendments to the Articles of Incorporation to be effective immediately."

In accordance with said resolution, these Articles of Amendment are hereby filed and the Articles of Incorporation of the Corporation are hereby amended as follows:

- 1. Article Four is hereby amended so that the aggregate number of shares which the Corporation is authorized to issue is 2,000, all of a single class and each having a par value of \$1.00.
- 2. Article Six is hereby amended so that the Corporation may have as many as four directors constituting the board of directors of the Corporation.

These two amendments to the Articles of Incorporation of the Corporation are effective immediately.
