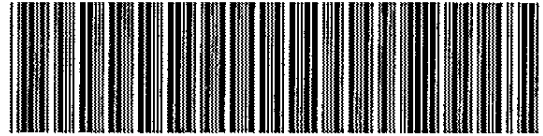

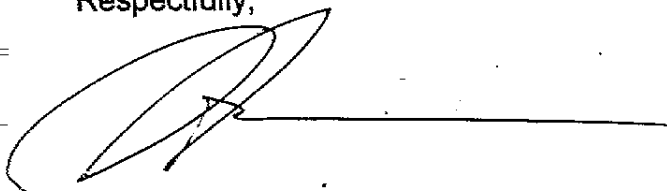

ARTICLE ONE

The name of the corporation is **TAFREESECO, INC.** The principal address of the corporation is: 2195 SW Ranch Trail, Stuart, Florida 34997.

The period of its duration is perpetual.

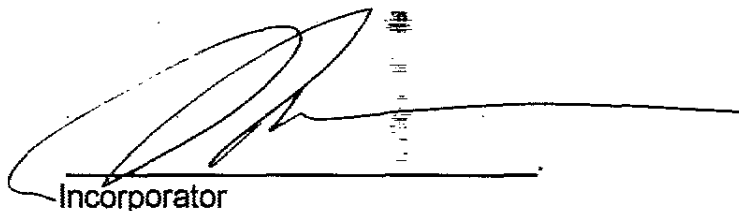
The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
