ARTICLES OF INCORPORATION

OF

D & M INVESTMENT PARTNERS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the corporation is: D & M Investment Partners, Inc.
- Article 2. Address. The address of the principal office of the corporation is 123 S. Lake, Lake Mary, FL 32746.
 - **Article 3. Duration.** The duration of the Corporation is perpetual.
- Article 4. Purpose. The general purposes of which the corporation is organized are the following:
- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
