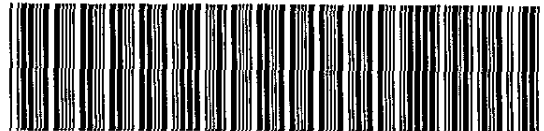

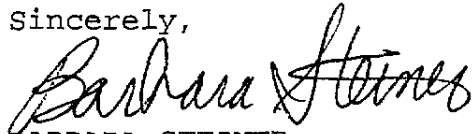

ARTICLE I-TRAVEL COUNTRY TOURS, INC.

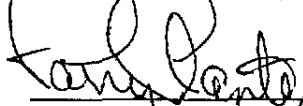

3. The foregoing amendment was unanimously approved by 100% of the shareholders and 100% of the board of directors.

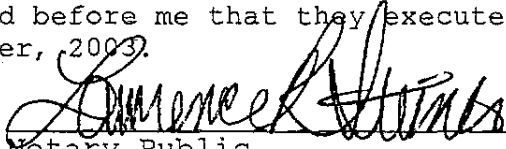
