ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. The name of the corporation is SANTE FE DEVELOPMENT, INC.
- 2. The address of the corporation is 4125 29th Place S.W., Naples, Florida 34116.
- 3. The period of its duration is perpetual.
- 4. The purpose or purposes for which the corporation is organized are to engage in any activity. or business permitted under the laws of the United States and the State of Florida.
- The corporation shall have authority to issue seventy-five hundred shares, all of one class,
 one dollar par value.
