ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

MOTEK SILVER BLUE CORP.

Pursuant to the provisions of section 607.1006, Florida Statutes, **MOTEK SILVER BLUE CORP.**, a Florida Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: **ARTICLE IV-RESTRICTIONS** of the Articles of Incorporation of **MOTEK SILVER BLUE CORP.**, a Florida corporation, is hereby deleted as originally stated and is amended to read as follows:

ARTICLE IV-RESTRICTIONS

Restrictions On Corporate Powers. The corporation, for so long as the Loan (defined below) is outstanding shall not:

1. Incur indebtedness except for the liability the corporation has as the managing member of **103 SILVER BLUE LAKE APARTMENTS LLC**, a Florida limited liability company, arising out of that certain Mortgage Note and a Mortgage, Assignment of Leases and Rents and Security Agreement ("Loan Documents") entered into and executed by **103 SILVER BLUE LAKE APARTMENTS LLC**, in favor of **UBS REAL ESTATE INVESTMENTS INC.**, evidencing an indebtedness in the original principal amount of \$5,650,000.00 (the "Loan");
2. Engage in any dissolution, liquidation, consolidation, merger or sale of assets or cause **103 SILVER BLUE LAKE APARTMENTS LLC**, to do any of the foregoing acts; and
3. Enter into transactions with affiliates that are not conducted on an arms length transaction basis and on a commercially reasonable terms;
4. Act or omit to act in any way which would result in the corporation being unable or incapable of serving in the capacity of the managing member of **103 SILVER BLUE LAKE APARTMENTS LLC**; and
5. The date of adoption of the amendments listed above, shall be as of the 30th day of September, 2004, and
6. The number of votes cast for the amendment by the shareholders was sufficient for approval.
