



THE UNDERSIGNED, subscribed to these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

#### ARTICLEI

The name of the corporation shall be:

# ARTICLEII

The general purpose of the corporation is to engage in any activities or businesses permitted under the laws of the United States and Florida, including, but not limited to the operation and management of a retail merchandise business.

#### ARTICLEIII

The term for which this corporation shall exist shall be perpetual and the business of the


