In compliance with the requirements of F.S. Chapter 607, the undersigned, RUDY WILSON, being a natural person, does hereby act as an Incorporator in adopting and filling the following Articles of Incorporation for the purpose of organizing a business Corporation.

#### ARTICLE I

The name of the Corporation is ENTREES ON TRAYS OF LAKE MARY, INC.

#### ARTICLE II
