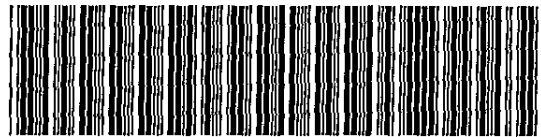

The following shall constitute the first officers of this corporation: Silko Razial - President, Secretary & Treasurer.


ARTICLE VI - TERM OF EXISTENCE


