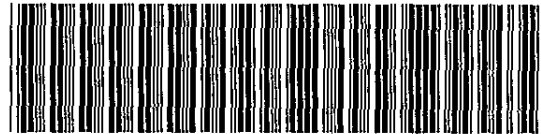

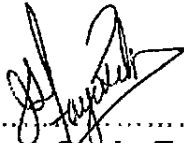

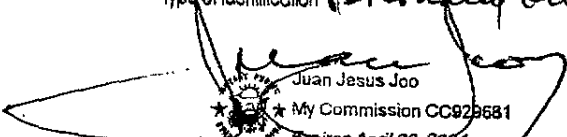
**SECOND:** The amendment provides for exchange of issued shares, are as follows:
