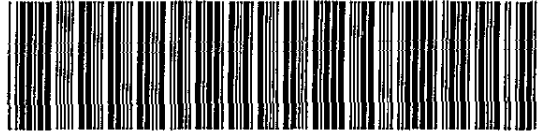

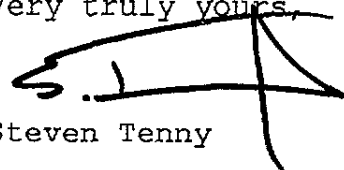

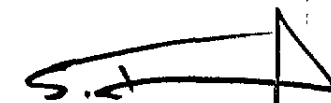
**AMENDMENT TO ARTICLES OF INCORPORATION
