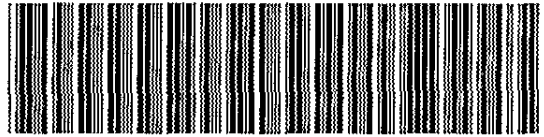

CAPITAL STOCK




