# ARTICLES OF INCORPORATION

# Southeast Concrete Systems, Inc.

The undersigned subscriber, a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

## ARTICLE 1

The name of this corporation shall be, Southeast Concrete Systems, Inc.

Its principal office shall be at 5323 NW Nassau Avenue, Port Saint Lucie, Florida 34983 or at such other place as may be designated, from time to time, by the Board of Directors.

#### ARTICLE JI


#### ARTICLE III
