The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

EFFECTIVE DATE  
11-5-02

The name of the corporation shall be SCC Services, Inc.

**ARTICLE II - COMMENCEMENT & DURATION**

The corporation shall commence its existence on November 5, 2002 and shall exist perpetually unless sooner dissolved according to law.

**ARTICLE IV - STATED CAPITAL**
