

ARTICLES OF INCORPORATION OF XPRESS PHARMACY SOFTWARE, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, ORIDA hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is **Xpress Pharmacy Software**, **Inc.** whose principal place of business is One Financial Plaza, Suite 2600, Ft. Lauderdale, FL 33394

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE IV

The corporation shall have the authority to issue one thousand (1,000) shares, all of one class of Capital Stock, with a par value of \$.10 per share.
