ARTICLE I - NAME

The name of this corporation is NHS LOGISTICS, INC., with its principal office and address being located at 891 N.W. 109th Terrace, Coral Springs, FL 33071.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.
