

# ARTICLES OF INCORPORATION

# ARTICLE 1 - NAME

The Name of the corporation is Leonel Enterprises, Inc.

# ARTICLE II - DURATION

The corporation shall have perpetual existence, commencing on January 1, 2003, unless sooner dissolved according to law.
